





Key Options for 2018 G20 Trade and Investment Agenda for Sustainable Development

Sunday 06 May 2018, 09:00-17:00, Buenos Aires, Argentina

SESSION OBJECTIVES

Ten years ago, in the immediate wake of the 2007-08 global financial crisis, the G20 was upgraded from finance ministers to a leaders' summit. A decade later, the 2018 meeting of the G20 Leaders' Summit will convene in the whirl of considerable trade friction and uncertainty. Can this self-designated premier forum for international economic cooperation guard the rules-based multilateral trading system and preserve an open economic order for inclusive and sustainable global development?

The Argentine G20 presidency will host its first meeting of the G20 Trade and Investment Working Group (TIWG) on 7-8 May 2018 in Buenos Aires. Established at the 2016 G20 Leaders' Summit, the TIWG serves as a platform to support trade ministers and leaders on trade and investment policy cooperation.

Against this backdrop, and in partnership with the Consejo Argentino para las Relaciones Internacionales (CARI), the Centro de Implementación de Políticas Públicas para la Equidad y el Crecimiento (CIPPEC), and the T20 Task Force on Trade, Investment and Tax Cooperation, ICTSD is organising a side event on Sunday 6 May, one day before the official TIWG meeting. ICTSD organised similar side events in Nanjing in 2016 and Berlin in 2017, which were both highly appreciated by participating officials.

The objective of this 2018 workshop is two-fold. First, to support TIWG officials in their reflections on what the G20 can and should do on trade and investment policy cooperation, with a focus on the multilateral trading system and protectionism, a sustainable food future, and an inclusive digital economy. Second, to offer a neutral space for information exchange and frank discussion outside of formal negotiating settings, where consensus-building can be facilitated and new ideas freely explored.
