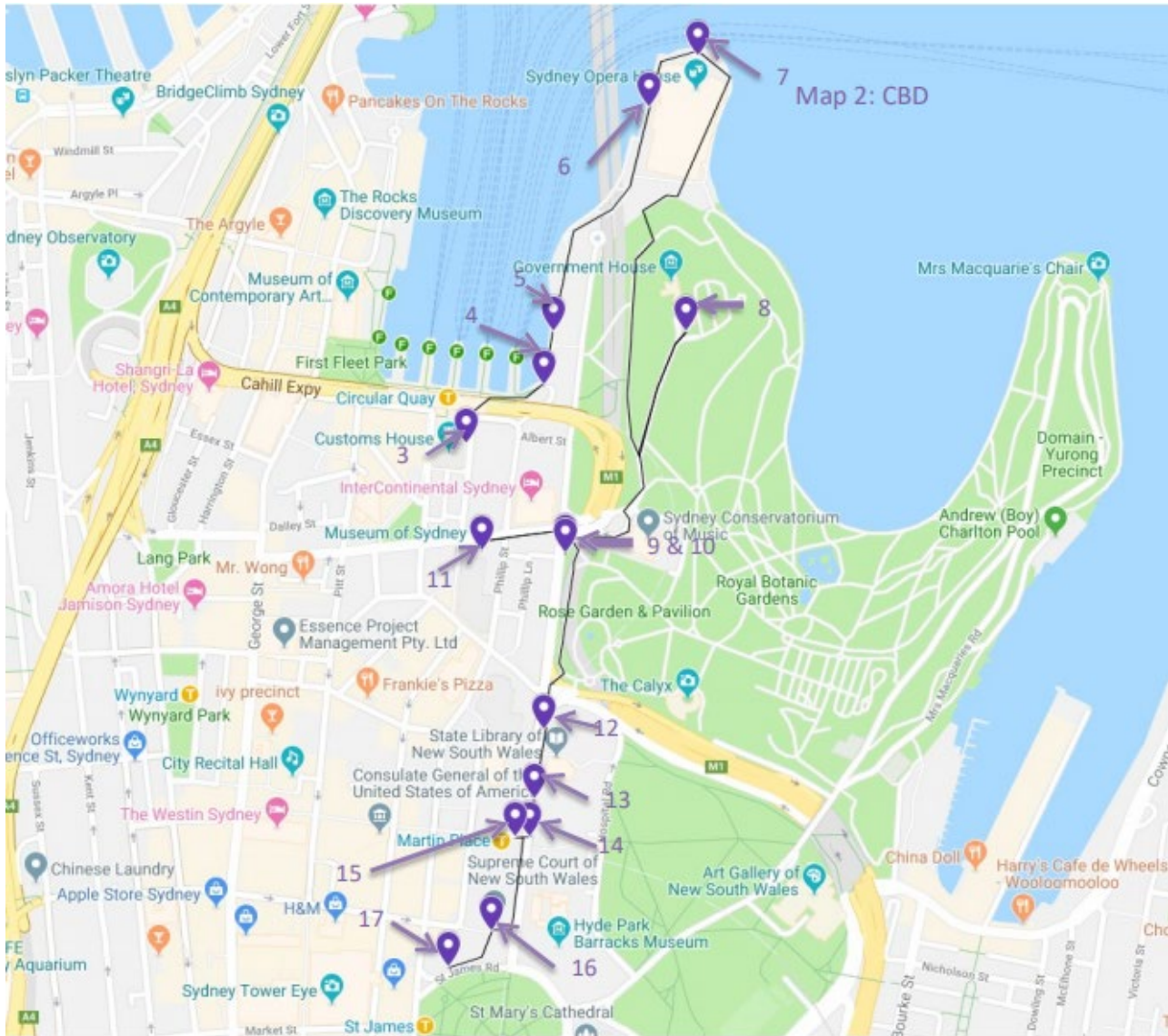

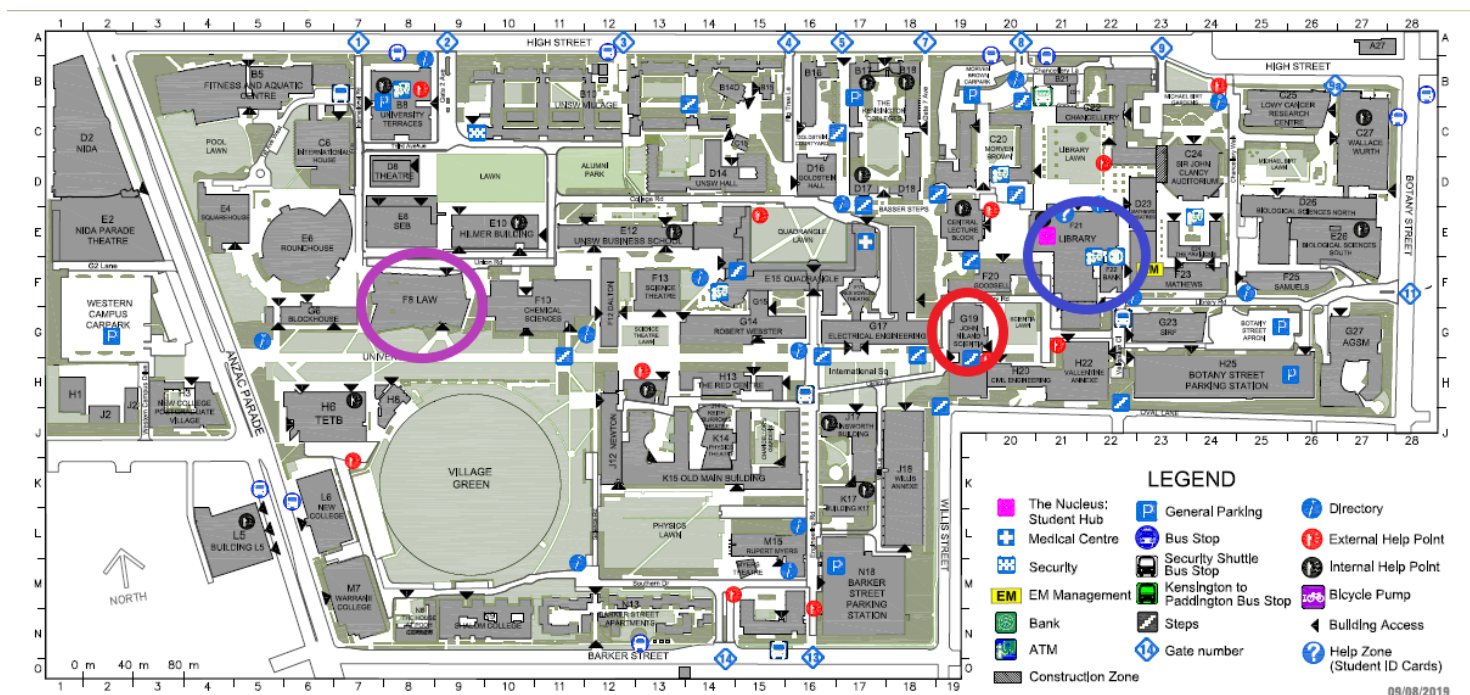

## **APPENDIX 1**

### **Session II Deans' Meeting: Prof James Speta's proposal**

#### **Proposal for a Committee on Programs, Pedagogy, and Curriculum Law Schools Global League**

The League members share a commitment to teaching law in a global context as well as conducting research on global legal issues. Members of the League also have programs that include significant numbers of international students, and even for each school's domestic students, League schools attend to global issues. This proposed Committee on Programs, Pedagogy, and Curriculum would investigate, develop, and share best practices across member institutions and, possibly, produce white papers, publications, and teaching materials.

Possible specific questions that such a Committee might include:

- What are best practices in teaching classes to multiple campuses simultaneously, using distance technology?
- What are the best practices around visiting student and/or dual degree programs?
- What are the state of the art comparative (or global) law teaching materials; can we supplement existing teaching materials where gaps exist?
- Can we identify best practices for multi-jurisdictional admissions and advocate to various regulators for those constructs?
- What are best practices for admitting and supporting international students?

One starting point might be a comprehensive survey and description of the League members' own programs, bringing up to date work done in this regard earlier in the League's existence. This would provide a strong basis for some of the other initiatives, as well as creating a resource for members to engage in bilateral cooperation.

We are seeking an expression of the League's interest in such a Committee. If approved, we will look to establish co-chairs or a small steering committee, begin to assemble a constituency, and launch our first projects to be reported out at the next summer meeting.
