1. Biography

I am currently a research professor in International Trade in the TRADE (Trade and Development) research focus area, NRF-rated researcher and WTO Chair holder at the North-West University (Potchefstroom Campus).

My status as an academic is based on my publications in the fields of Competitive Intelligence and Export Promotion which appear in more than 50 peer-reviewed journals, book chapters and national policy reports. My work and contribution to research, policy and practice aimed at improving/promoting South Africa's exports, are internationally recognised and acknowledged.

My research on export promotion has made a particularly significant contribution in respect of the development of a scientifically-based decision support model (DSM) that identifies South African export opportunities, which is an enduring national priority. This research has influenced national policy formulation and implementation in South Africa.

I have successfully supervised 11 PhD and 22 Master's students (some of whom have been award winners in their own right), and chaired workshops for various stakeholder groups both within South

Africa and abroad on academic as well as practitioner-relevant matters. I sit on several editorial boards and national and international committees, which provides additional evidence that a wide cross-section of organisations and decision makers hold my research in high regard.

I have received many research grants and a number of prizes, including a Fellowship from ITRISA (International Trade Institute of Southern Africa) for my contribution in extending the scope of international trade-focused education and research in South Africa; the 'Women in Research Award' from the South African Association of Women Graduates; five university teaching excellence awards; and the Department of Science and Technology's 'Distinguished Women in Science Award' first runner-up in the Social Science and Humanities category.
