Course Description

This course covers the World Trade Organization (WTO) and its regulatory regime for international trade. It covers the origins, institutions, and agreements of the organization. It focuses on the past, present, and the future of the organization, encouraging candidates to grapple, in particular, with the role of African Members in the organization.

Course Objectives

The broad objective is to provide advanced knowledge and understanding of the World Trade Organization: the institutional framework and its rules. Specifically, the course aims to:

- Capacitate candidates with knowledge on the origins and the development of the WTO;
- Instil advanced knowledge of the WTO's institutional framework, principles, and rules, as reflected in key covered agreements;
- Encourage discussion and reflections on the politics of the international trading system, in particular the role developing countries in the system;
- Encourage discussion and reflections on the future of the WTO.

Core Competencies

At the end of the course, each candidate should be able to exhibit:

- Advanced understanding of the history and development of the WTO.
- Advanced understanding of the WTO institutional structure, principles, and rules;
- Advanced understanding of the common perspectives of developing countries, broadly, and African countries, in particular, on the WTO regulation of international trade;
- Skills in researching on WTO issues;
- Writing skills, including the ability to write analytically, in a cogent, structured, and logical manner, citing authorities from various academic sources;
- Presentation skills, by making compelling arguments related to the course content.

Teaching & Learning Methods

This module is taught remotely using the Zoom platform.
