# CURRICULUM VITAE: DR ADELIA JANSEN VAN RENSBURG



## **SUMMARY PROFILE**

**Dr Adelia Jansen van Rensburg** is currently a senior lecturer in the School of Economic Sciences at the North-West University (NWU), Potchefstroom Campus, South Africa, a position she has held since 2019. In this role, she contributes to teaching and learning, research and innovation, community engagement, and leadership development. Adelia is a trade economist by profession, specialising in international trade, trade policy, and trade policy development. Adelia was appointed as South Africa's WCP Chair holder in November 2024. She is well acquainted with international trade rules, the role and work of the WTO, and regional trade agreements (RTAs) and how the latter fit into the broader multilateral landscape. Adelia holds a PhD in International Trade, which she obtained from NWU in 2009.

Before joining NWU's School of Economic Sciences, Adelia was a postdoctoral fellow in the NWU's TRADE research focus area (2017–2018). Her supervisor and mentor during this period were established researcher, director of TRADE, and former WTO Chair holder, Prof. Wilma Viviers. As a postdoctoral fellow, Adelia was also very involved in the work of the WTO Chairs Programme (WCP), including conducting research on trade policy issues, contributing to the refinement of the University's trade curriculum, and arranging and participating in various outreach activities.

Prior to joining the University, Adelia served as a trade diplomat with the Southern African Customs Union (SACU) Secretariat in Windhoek, Namibia (2010–2016). As trade negotiations coordinator in the Directorate: Trade Policy Development and Research, she was responsible for facilitating and coordinating SACU's trade negotiations agenda and work programme. Key focus areas included assisting SACU's decision-making bodies in formulating economic and trade policy positions and mandates and overseeing their implementation; managing the Africa and America trade desks (specifically negotiations and agreements); providing technical assistance and advice on various bilateral and regional negotiations; and initiating and managing research initiatives covering trade policy development. While at SACU, Adelia attended numerous heads of state and government meetings, ministerial meetings, senior trade and finance officials' meetings, and trade negotiations.

Adelia has a particular passion for teaching, inspired by William Arthur Ward's philosophy: "The mediocre teacher tells, the good teacher explains, the superior teacher demonstrates, and the great teacher inspires." She is actively involved in the School of Economic Sciences' Economics and International Trade Programme, where she teaches International Trade Relations—her favourite subject in the curriculum. She also teaches an introductory macroeconomics course and an online Introductory Economics course covering key economic, trade, and trade policy concepts, with a particular focus on South Africa.

On the research side, Adelia has been a member of NWU's TRADE research focus area and the WTO Chairs Programme (WCP) since 2017, under whose auspices she has contributed significantly to the University's research outputs. Her research specialisations include the international trading system, trade policy dynamics, geopolitics and geoeconomics, and regional integration, with a special focus on South Africa and Africa. She is also interested in the ideological tension between the multilateral trade policy approach advocated by the WTO and regional trade arrangements, in new-generation trade issues, and in the evolution of deep trade agreements. Adelia is passionate about helping researchers and policymakers alike to enhance their knowledge and understanding of the evolving geopolitical order and the international trading system, and how policymakers can use trade policy as a tool to unlock their countries' trade and economic potential.

To date, she has co-authored several journal articles, book chapters, books, and other publications. Her research broadly covers international trade and trade policy. She has published on multilateral and WTO-related topics, such as the impact of plurilateral trade agreements on developing countries and how the G20 can help sustainably reshape the global trade system; trade liberalisation and its continued importance, such as the liberalisation of Bangladesh's services trade; issues surrounding trade negotiations, such as developing product-level prioritisation methods for bilateral trade negotiations; and new-generation trade policy matters, including the development of a services trade strategy for South Africa and the harmonisation of digital trade policies in Africa. Her research also examines regional groupings, both in Africa (such as the African Continental Free Trade Area [AfCFTA]) and in other parts of the world (such as the Indian Ocean Rim Association [IORA]).

One of Adelia's recent publications is a book titled Africa's Digital Future: From Theory to Action, which provides an overview of Africa's digital trade policy landscape and offers strategic guidance to decision-makers on how to optimise digital technologies to drive the continent's growth and development. The book explores how Africa can benefit from the digital age, despite challenges related to development and technological adoption.

Over the years, Adelia has engaged extensively with government, academic, and public and private sector stakeholders, building an extensive professional network in the international trade field. She has maintained a longstanding and close working relationship with South Africa's Department of Trade, Industry and Competition (DTIC), which began in 2007 with the establishment of NWU's Export Promotion Research Group (EPRG). The EPRG provided

export promotion support to the DTIC and Trade and Investment South Africa (TISA). One of the projects in which Adelia was involved focused on enhancing South Africa's economic growth prospects by identifying the country's most viable export opportunities. Many of the group's contributions were captured in the book Export Promotion: A Decision Support Model Approach, edited by Prof. Ludo Cuyvers and Prof. Wilma Viviers, for which Adelia served as a reviewer.

Notably, in 2017–2018, Adelia was part of the team that developed a strategic framework and action plan for the export development and promotion of South Africa's services sector. She continues to work closely with the DTIC and Ambassador Xolelwa M. Peter, South Africa's former WTO Ambassador and Deputy Director-General for Trade, on areas of mutual collaboration. Their most recent research project—based on Ambassador Peter's Master's dissertation in International Trade—focuses on reforming the WTO Dispute Settlement System for developing countries, with an emphasis on enhancing accessibility and inclusivity for countries such as South Africa. They have also initiated discussions on potential future collaborations aimed at strengthening the alignment between academic research and trade policy practice.

Over the years, Adelia has been an active member of various international trade, trade policy, and economic development bodies. These include NWU's International Trade Programme, the TRADE research focus area, the WTO Chairs Programme at NWU, the Going Digital Think Tank at NWU, Trade Research Advisory (TRA), the Export Promotion Research Group (EPRG), the Economic Society of South Africa (ESSA), and SACU's Professional Staff Forum.

Adelia's achievements include being appointed WTO Chair in 2024, receiving a postdoctoral WCP bursary in 2018, an NWU postdoctoral fellowship (and grant) for 2017–2018, and a National Research Foundation (NRF) doctoral scholarship for 2005–2009. These awards were granted in recognition of her exceptional academic performance.

## **WORK EXPERIENCE**

## Senior Lecturer, NWU, 2019-the present

#### **Duties and achievements**

Adelia's primary responsibilities as a senior lecturer at the NWU is to contribute to the University's teaching and learning, research and innovation, community engagement and leadership activities. Since 2019, she has taught a compulsory second-year course to all students enrolled on the International Trade Programme, called International Trade Relations. She also teaches a first-year course, called Introductory Economics, for the Human Resource Development Programme, which covers key economic concepts but with a South African focus. She also taught Economics 101 to all students enrolled on the Economics Programme in 2019 and a Personal Finance module in 2008–2009. In addition, Adelia has supervised several PhD, Master's and Honours students.

Adelia's other responsibilities in her role as a senior lecturer include assisting with the development, management and monitoring of undergraduate and postgraduate programmes, modules, and courses. This involves administration, curriculum development, quality management, and programme/course enhancement. Regarding curriculum development, the aim is to ensure the efficient and effective delivery of programmes in accordance with the University's strategy, policies, and procedures, while also conveying the latest developments in the international trade field. To this end, Adelia works closely with colleagues in the School of Economic Sciences, the TRADE research focus area, the Faculty of Economic and Management Sciences, and the other campuses.

Under teaching and innovation, Adelia is expected to contribute to the research outputs of the University. In this regard, Adelia has written several papers, book chapters and books covering a wide range of topics, but with an emphasis on the latest developments in trade, trade policy and regional integration. Much of her research has been published in peer-reviewed and high-impact academic journals and presented at local and international conferences. Adelia liaises closely with other academic institutions, government bodies and the private sector, where she uses her knowledge and experience to influence thought leadership and cutting-edge practice, especially in the area of trade policy development.

## Postdoctoral Research Fellow, NWU, 2017–2019

#### **Duties and achievements**

As a postdoctoral research fellow, Adelia's primary responsibilities were: (i) to bring new and innovative ideas to the TRADE research focus area, (ii) to contribute to the research outputs of the University through the publication of articles in peer-reviewed journals and books/book chapters, and (iii) to contribute to the University's postgraduate study programme by cosupervising students. Adelia's postdoc work added to the outputs of the School of Economic Sciences, the TRADE research focus area, and the WTO Chairs Programme (WCP).

During her time as a postdoc fellow, Adelia co-authored four peer-reviewed articles in high-impact journals; co-authored two book chapters and two WTO publications; attended two national conferences and one international conference; contributed to three major research projects; and co-authored four research reports. She also co-supervised one PhD student (assistant promoter) and one Master's student (co-supervisor); examined two postgraduate courses; reviewed two journal papers; delivered six special lectures; and participated in over 25 meetings, seminars, workshops and conferences. She also shared her knowledge of trade (and specifically trade policy in Africa) with colleagues, students, and various national and international stakeholders. Adelia was also awarded a WTO bursary under the WCP programme in her second year as a postdoc fellow.

#### **Duties and achievements**

Adelia was a trade negotiations coordinator in the Trade Negotiations Unit and Policy Development & Research Directorate of the SACU Secretariat over the period 2010–2016. Her main responsibilities were to assist SACU with the formulation and implementation of its trade policy positions and mandates and to help manage (and implement) its trade negotiations agenda and work programme. Most of this work involved Adelia helping to draft and table reports and other documents for SACU decision-making entities, including the SACU Summit (heads of state and government), the SACU Council of Ministers, the SACU Commission (consisting of SACU senior trade officials), and the negotiations team or technical officials (represented by government officials in trade, industry, and finance).

During her time at SACU, Adelia participated in several trade negotiation rounds and helped with the implementation of various trade agreements. She was responsible for the Africa and America desks (particularly with respect to trade negotiations and agreements). Work on the Africa desk revolved around the SACU Agreement, the SADC Protocol on Goods and Services, the SADC–EAC–COMESA Tripartite Free Trade Agreement (TFTA), the African Continental Free Trade Area (AfCFTA) Agreement and the African Growth and Opportunity Act (AGOA). Adelia also participated in other African trade and trade policy activities, including meetings of the African Union (AU) and meetings of African ministers of trade, who often had discussions before the upcoming WTO Ministerial or on the fringes of AGOA meetings. Work on the America desk revolved around the Trade, Investment and Development Cooperation Agreement (TIDCA) between SACU and the US, AGOA, the GSP (US and SA) and the SACU–Southern Common Market (Mercosur) Preferential Trade Agreement (PTA). From time to time, Adelia also covered the European and Asia desks, which saw her participate in the WTO Trade Policy Review process, implementation of the EFTA–SACU Free Trade Agreement (FTA), exchange of tariff offers under the SACU–India PTA, among other activities.

In addition, a significant part of Adelia's work during her time at SACU involved the initiation, facilitation, and management of research activities. In this regard, Adelia wrote many background, guiding, concept and strategic papers in support of SACU's trade negotiations work, with much of the underlying research work centring on measuring and recording the effects of new trade agreements on SACU and the accession of new member states on current trade agreements to which SACU was a signatory. Adelia also provided advice, guidance and technical assistance on a range of bilateral, regional, continental and multilateral trade issues both to the SACU Secretariat and its member states. Adelia also assisted with the methodical aspects of the trade negotiation process, such as the development of tariff offers or schedules of commitments for third parties and helping others to grasp the technical aspects of trade, including sanitary and phytosanitary (SPS) measures, technical barriers to trade (TBT), non-tariff barriers (NTBs), rules of origin (ROO), dispute settlement rules, trade in services, investment promotion activities, and other topics.

## Study Leader for International Trade Honours Students, NWU, 2009

#### **Duties and achievements**

In 2009, while completing her PhD, Adelia was a study leader for a group of International Trade Honours students. Her duties involved basic student management and supervision of their research activities, most of which focused on export promotion. She also provided mentoring and guidance to students and helped with the marking of their dissertations.

## Co-Founder/Director: House of Prayer, Potchefstroom, 2005–2009

### **Duties and achievements**

Between 2005 and 2009, while busy with her PhD, Adelia co-founded and managed a non-profit organisation called House of Prayer (HOP) in Potchefstroom. HOP aimed to love, serve and better the lives of the local community through various outreach programmes. Adelia's responsibilities mainly entailed the provision of strategic guidance to HOP and its staff; human

resource management (the board and staff); project management (planning, organising, motivating, controlling, and managing resources, procedures and protocols to achieve specified goals); and financial management (especially managing the budget). She also oversaw the organisation's social responsibilities, public relations, fundraising and marketing activities.

## Junior Lecturer in Personal Finance, NWU, 2008–2009

#### **Duties and achievements**

In 2008–2009, while working on her PhD, Adelia taught a compulsory first-year BCom course at the NWU, called Personal Finance. The aim of the course was to equip students with the knowledge and skills to manage their personal finances more effectively. Her work involved delivering lectures and tutorials, and assessing students' course work through assignments, tests, and examinations. She also supported students by assuming a pastoral/advisory role.

## Tutor/Academic Assistant, NWU, 2000, 2001 and 2004

### **Duties and achievements**

In 2000, 2001 and 2004, Adelia was a tutor and academic assistant for Economics and Macro Economics (both second-year BCom courses) and Business Ethics (a third-year BCom course) at the NWU. Her work involved delivering tutorials to a small group of students who needed additional support, assessing students' coursework, setting and marking tests and examinations, and playing a guidance/advisory role.

A report was compiled and a paper published in the *South African Journal of International Affairs*. This project involved Adelia visiting Dhaka, Bangladesh, from 1–8 April 2017 together with Ali Parry, a member of the TRADE and WCP teams.

### Department of Trade, Industry and Competition (DTIC)

Adelia participated in a research project that TRADE conducted for South Africa's Department of Trade, Industry and Competition (DTIC) titled "Design of a Strategic Framework and Action Plan for the Export Development and Promotion of South Africa's Service Sectors".
