This project aims at collecting, analyzing, and classifying the type of assessment tasks that are used to evaluate graduate students' learning and achievement in the four colleges of humanities and social sciences and create an online repository with recommendations to be used by different stakeholders. The motivation behind the idea is to enhance the current practice of assessment task design in these four colleges by creating an online repository that can (a) help us develop quality assessment tasks by having access to a variety of these tasks, (b) do a benchmark to ensure the quality of the assessment tasks, and (c) considering potential ways generative artificial intelligence (Gen AI) tools could be incorporated in the assessment tasks. This is especially important, given new advances in Gen AI tools like ChatGPT and the impact these might have on assessment task design. We will collect the assessment tasks currently in use in different programs in the four colleges of humanities and social sciences, namely, College of Humanities and Social Sciences (CHSS), College of Law (CL), College of Public Policy (CPP), and College of Islamic Studies (CIS). We will analyze and classify these assessment tasks based on their genre and rubrics and use of Gen AI tools and create an assessment task repository and bank with recommendations that can be used by different stakeholders. We may also interview some faculty from each of the colleges to obtain more information about some of the assessment tasks that need further clarification. Once we have a full data bank, we will recruit a website designer to design an online

social media companies may also not be conducive to tackling hate speech. Tackling hate speech and polarization requires multilateral efforts involving the companies themselves, academic and civil society. Despite the widespread adoption of social media in the MENA region, most efforts in tackling hate speech also tend to focus on the developed world, with little research targeting Arabic. Without adequate, contextual-based research, countries in the developing world in particular risk becoming social media blackspots - spaces where hate speech flourishes in unregulated and permissive online environments.

The main aim of this project is to address this gap and pave the way for further research on Polarization and Hate Speech in Arab societies. The research will address different problems that contribute to the detection of polarization and hate speech: 1) Stance detection with respect to controversial topics (a topic generating a polarized discussion: in favor vs. against); 2) Identification of polarized communities; 3) Hate speech detection; 4) Bot versus human identification and 5) Behavioral interventions to address hate speech. These components will be considered from a holistic perspective unlike some of the existing research works, which address them as isolated problems. By taking into account the legal, the behavioural and the ethical dimensions of the software solutions as well as data protection considerations, the project plans to create tools that will allow others to use them to detect polarization, hate speech, and bots.

	Countries in the Gulf Region and beyond have established 'international courts' to deal mostly with commercial law matters. Prominent examples are the Qatar International Court and Dispute Resolution Centre (QICDRC), the QFC Regulatory Tribunal, the Dubai International Financial Center (DIFC) Courts, the Abu Dhabi Global Market (ADGM) Courts, and the Singapore International Commercial Court (SICC). These courts are established by the governments of the respective countries; what makes them international is their composition, since they are composed of judges from another jurisdiction, typically a common law country, but also their subject matter jurisdiction, since the dispute typically requires a foreign element for these courts to assume jurisdiction. They are thus domestic courts with int'l judges and some offshore relevance. There are many rationales behind the creation of these courts: (a) attracting foreign capital: Countries with less established legal systems want to attract foreign direct investment by making credible commitments to foreign investors that their cases will be adjudicated in a fair way; (b) becoming a dispute resolution hub: there is also the willingness for some jurisdictions to establish themselves as global dispute resolution fora. Dispute resolution is thus viewed as a global service that can potentially attract foreign capital to the respective jurisdictions. Accordingly, there is both a domestic and an int'l dimension why countries globalize their dispute resolution systems.

Blockchain: Techno-Social and Legal Challenges (OUP 2019 – co-edited by Philipp Hacker, Ioannis Lianos, Georgios Dimitropoulos and Stefan Eich).

The project provides an in-depth analysis of the intersection between blockchain technology and the law. Covering EU, US, and Asian jurisdictions, it assesses the necessities of and opportunities for the regulation of blockchain technology in a range of key legal fields, such as competition law, securities regulation, corporate, insurance, contract, and data protection law. Instead of postulating the disruptive superiority of distributed ledger technology across potential areas of application, however, the volume offers a nuanced treatment of use cases ranging from early applications in finance to ICOs, alternative dispute resolution platforms, and smart contracts. It takes a distinct techno-social perspective in understanding the legal implications of blockchain technology as a possible new general-purpose technology. The interaction of blockchain technology with the legal system raises key questions concerning governance and government, private order and state authority, and the relationship between different 'calculative' spaces for assessing and allocating value. These questions do not only have a long pedigree, they are also acutely relevant to our immediate future. By drawing on technological, political, economic, and legal points of view, the project shows why blockchain matters for societies, and why the law matters for blockchain.
